## **QUESTION 1**

She occasionally suffers from pains in her abdomen, hence she went to see a doctor for advise and treatment. Dr Mandla advised her that she would need an operation for this treatment and further informed her that although the operation was likely to bring the pains in her abdomen to an end, unfortunately she may from time to time experience difficulties when having sexual intercourse. Mrs Adibo nevertheless freely and voluntarily gave Dr Mandla her consent to proceed with the operation and the operation is due in two weeks time. Somehow Mr Adibo has learnt about this looming operation and when he confronts his wife about it, she is adamant that she is going ahead with it. He proceeds to Dr Mandla who also informs him that he has secured the necessary consent from his patient and will, as planned, proceed with the operation on its due date.

- (a) Can Mr Adibo stop this operation on his wife from going ahead? Whichever side you take, please provide a legal basis for your stance. (20)
- (b) What is the effect of withdrawal of consent by a patient? (5)
