Sizwe Zondi, the biological father of the children, is also married to another woman but sees his children after every two weeks. The agreement of seeing the children after two weeks is at times violated by Sizwe who forgets to pick them up. Zandile and new husband expected that their marriage and family life together would be smooth sailing and they were both excited about creating a new family life together. The children, however, appear very strained when they are relating to their step father and they seem resentful about the new marriage. Zandile's new husband feels that he has to discipline the children as their father, but Zandile yelled at him, telling him that the children were her responsibility since she was their biological parent. 1.1 What type of family form does the family in the above passage represent?
