QUESTION 1

Below follows a list of clauses from testators' wills. In each instance C was already conceived at the time of the testator's death but was only born alive after the testator's death. Indicate in which one of the following examples C would not be able to inherit:

- a) "I bequeath my estate to my children". At the time of his death, the testator had two children, A and B, and his wife was expecting a third child, C.
- b) "I bequeath my estate to my children A and B, and any other child(ren) that my wife expects at the time of my death". The testator had two children, A and B and his wife was expecting a third child, C.
- c) "I bequeath my estate to my children who are alive at the time of my death". At the time of his death, the testator had two children, A and B, and his wife was expecting a third child, C.
- d) "I bequeath my estate to my children A and B." At the time of his death, the testator had two children, A and B, and his wife was expecting a third child, C.

Mthoko, who was born in Germiston and at the age of three moved to Bloemfontein with his parents, has recently qualified as a lawyer. He dislikes living in Bloemfontein intensely, but is unsure where he would like to live. He decides to spend a month in Cape Town while he decides where he would like to settle permanently. Where is Mthoko domiciled? Fully substantiate your answer.

QUESTION 3

Gabi, a seventeen (17) year old minor, concluded a contract with a certain

Mrs Thring, an adult, to rent a bachelor flat. In terms of the contract, Gabi

has to pay Mrs Thring the exorbitant amount of E3, 500.00 per month rental

for the flat. Gabi's father was unaware of this contract. When Gabi later had

difficulty in paying the rental, she phoned her father and told him about the

contract, whereupon he gave her money to pay six months' rental. Discuss in

detail whether, and if so, under what circumstances, the contract between

Gabi and Mrs Thring can be set aside by the Court.

QUESTION 4

Mr and Mrs Mdluli, wealthy farmers from the south, have a 21 years old son,

Sibhaha, who is currently earning no income because he is a full time Uniswa

student. Sibhaha and his girlfriend, Nconco, have an extra-marital son, Sbu.

a) Mr and Mrs Mdluli are not sure whether they are still legally obliged to

support Sibhaha now that he has reached majority. Advise them in

this regard with reference to case law.

b) Since Sibhaha earns no income, he cannot assist Nconco in making a

contribution towards Sbu's maintenance. Mr and Mrs Mdluli are of the

view that they are not responsible for Sbu's maintenance. Explain to

them the position of the law in Swaziland, with reference to recent

constitutional developments in the country.
