QUESTION ONE

Rajid Sayeed is an adult Swazi male of Indian Origin. He has lived in Swaziland for the past 25 years, during which period he applied for Swazi Citizenship. After following all the required channels, he was duly granted and even obtained land under the traditional land acquisition procedure under Chief Msolwa. He further obtained the Swaziland Personal Identification Number. During his stay under the chiefdom, he participated in all the traditional ceremonies and even joined the local community police watch group.

Whilst going about his duties one day, he got into a fight with one of his socialite friend, Simo Gina who had just been enrolled for a Diploma in Law Course at the University of Swaziland. Rajid was the first one to arrive at the Police Station where he laid a complaint of assault against Simo. The latter was apprehended and charged for common assault. On the 1st date of the hearing at the Swazi Court Simo raised an objection to the jurisdiction of the court in terms of Section 28 of the Swazi Court's Act No. 80 of 1950.

Advise the presiding officer, in detail, of the composition, jurisdiction, and the law that the Act empowers these courts to apply.
