QUESTION 1

Your client is Sibongile Matse. Her husband Phila Matse has died. Whilst on his death bed, he asked his second wife to write his will, and she signed it on his behalf, seeing as he was too weak to summon the energy to sign it himself. Phila Matse's estate is quite substantial as it comprises of a shopping complex at Beverly Hills (a suburb in Mbabane), Unit Trusts at African Alliance, various shares and debentures from companies based in Swaziland and in South Africa, and 4000 head of cattle at his farm at Luve, in Manzini.

Phila married both his wives according to customary rites. Sibongile wishes the estate of her late husband to be wound up under the supervision of the Master of the High Court. However, her in laws insist that although Sibongile is the first wife, she has limited authority in such matters. They insist that the Swazi Law and Custom should be applied in the devolution of this estate.

Advise your client on all this. She informs you that the will, although signed by Phila's second wife, was duly signed by a Commissioner of Oaths.

Your client has furnished you with her letters of Administration (issued to her by the Master of the High Court in Chile). She informs you that she wishes to commence the administration of the portion of her mother's estate that is situated in Swaziland.

Advise your client on the legal requirements as stated in the Administration of Estate Act, 1902. (25 marks)
