Due to devastating effects of drought, a community in the Shiselweni region, has had to withdraw their young primary school-going children, from school, due to poverty and resultant hunger and failure to pay school fees charged by the school. Most of the children have resorted to seeking employment with a local cotton farmer who pays each child E10.00 for a week's labour. The children report that the conditions in the farm are unbearable as they are made to work without any breaks and at times they have nothing to eat.

You are a member of a local NGO and one of the children's parents has approached you for assistance.

You must help her by answering the following questions:

(a) What do you think would be the concerns of the parents, teachers/ school authorities and learners? Make a list of the concerns of each of these groups.

(b) What rights do you think are being infringed in this case study? Name the rights that are being infringed and the source of the right.

(c) What would be the possible rights-based responses that they could take up? [10 marks]
